

# Z-Gold Exploration Closes a \$32,000 Private Placement

The placement consists in 388,571 flow-through shares at a price of \$0.07 per share representing an amount of \$27,200 and 80,000 common shares at a price of \$0.06 per share representing a total amount \$4,800. Each share is accompanied of one-half (1/2) share purchase warrant. Each whole warrant gives the right to subscribe for one common share of the Corporation at a price of \$0.11 per share, expiring January 13, 2014.
