## Denison Mines Corp. Completes C\$14,997,150 Flow-Through Share Offering

TORONTO, ONTARIO -- (Marketwired - Aug. 12, 2014) - <u>Denison Mines Corp.</u> (TSX:DML) (NYSE MKT:DNN) ("Denison" or the "Company") announces that it has completed its previously announced private placement offering (the "Offering") of common shares (the "Flow-Through Shares") issued on a "flow-through" basis pursuant to the Income Tax Act (Canada).

At closing today, 9,257,500 Flow-Through Shares were issued through a syndicate of underwriters led by Dundee Securities Ltd. and including Paradigm Capital Inc., Raymond James Ltd., Scotiabank, BMO Capital Markets and Cormark Securities Inc. (the "Underwriters"), at a price of C\$1.62 per Flow-Through Share, for aggregate gross proceeds to Denison of C\$14,997,150. The proceeds include C\$1,956,150 from the issuance of 1,207,500 Flow-Through Shares purchased pursuant to the over-allotment option granted to the Underwriters. The Flow-Through Shares are subject to a four-month hold period which will expire on December 12, 2014.

The proceeds of the Offering will be used to incur eligible Canadian Exploration Expenses for purposes of the Income Tax Act (Canada) relating to the Company's Canadian uranium mining exploration projects, which will be renounced to the subscribers with an effective date no later than December 31, 2014.

Including the high grade Phoenix deposits, located on its 60% owned Wheeler project, Denison's exploration project portfolio includes numerous projects and totals over 470,000 hectares in the Eastern Athabasca Basin region of Saskatchewan. Denison's interests in Saskatchewan also include a 22.5% ownership interest in the McClean Lake joint venture, which includes several uranium deposits and the McClean Lake uranium mill, one of the world's largest uranium processing facilities, plus a 25.17% interest in the Midwest deposit and a 60% interest in the J-Zone deposit on the Waterbury property. Both the Midwest and J Zone deposits are located within 20 kilometres of the McClean Lake mill. Internationally, Denison owns 100% of the conventional heap leach Mutanga project in Zambia, 100% of the uranium/copper/silver Falea project in Mali, a 90% interest in the Dome project in Namibia, and an 85% interest in the in-situ recovery projects held by the Gurvan Saihan joint venture in Mongolia.

Denison is engaged in mine decommissioning and environmental services through its DES division and is the manager of Uranium Participation Corporation, a publicly traded company which invests in uranium oxide and uranium hexafluoride.
