TORONTO, ONTARIO -- (Marketwired - Aug. 15, 2014) - <u>Pelangio Exploration Inc.</u> (TSX VENTURE:PX)(OTCQB:PGXPF) ("Pelangio" or the "Company") is pleased to announce the closing of its previously announced private placement of 15,000,000 units of the Company at a price of \$0.04 per unit for gross proceeds of \$600,000 (the "Private Placement").

Each Unit sold pursuant to the Private Placement is composed of one common share (a "Common Share") and one-half of one common share purchase warrant (each whole purchase warrant, a "Warrant"). The proceeds of the Private Placement will be used for continued exploration at our Ghana properties, including up to 3,000 metres of air core and reverse circulation drilling, and for general working capital purposes, which will include consulting fees and salaries, including to officers and other employees.

The Company will pay a finder's fee of \$13,510 to certain introducing parties in respect of a portion of the proceeds of the Private Placement, subject to compliance with applicable securities legislation and TSX Venture Exchange policies. The Private Placement is subject to receipt of all necessary regulatory approvals, including the TSX Venture Exchange. The securities issued pursuant to the Private Placement will be subject to a four month hold period in accordance with applicable Canadian securities laws, expiring December 16, 2014. Certain directors and/or officers of the Company are participating in the Private Placement for a total of 6,500,000 units.
