VANCOUVER, BRITISH COLUMBIA -- (Marketwired - Jan. 5, 2015) - [Carmax Mining Corp.](#) (TSX VENTURE:CXM) ("Carmax" or the "Company") has filed documentation with the British Columbia Securities Commission to change its year end to October 31.
