

Alder Resources Completes Shares for Debt Settlement

TORONTO, Feb 26, 2015 - [Alder Resources Ltd.](#) ("Alder" or the "Company") (TSX VENTURE:ALR) has completed the share for debt settlement with a former officer of the Company that was previously announced in the press release dated February 13, 2015. The Company issued 993,740 common shares of Alder (the "Common Shares") at a deemed price of \$0.05 per Common Share as part of the debt settlement. The shares for debt settlement represents the full and final satisfaction of \$49,687 owing to the former officer for outstanding management and consulting fees.

The Common Shares remain subject to a statutory hold period of four months and one day and final approval of the TSX Venture Exchange.

About Alder Resources Ltd.

Alder is a resource company focused on the development of gold and base metal projects throughout the Americas. Alder's current high priority Cu-Au-Ag porphyry target is the Rosita project in Nicaragua located 275 kilometres northeast of Managua. The company has current Inferred mineral stock pile resources of 7.95 million tonnes grading 0.62% Cu, 0.46 g/t Au and 9.21 g/t Ag with numerous zones that have good near term potential to add to and enhance these resources. In August 2011, Alder entered into an option agreement to acquire a 65% interest in the Rosita D concession from [Calibre Mining Corp.](#) by issuing 1,000,000 shares and incurring expenditures of \$4,000,000 over four years. To date Alder has incurred approximately \$3.5 million of the \$4.0 million obligation and has until October 2015 to incur the remaining project expenditures.
