

Toronto, Ontario / TheNewswire / April 11, 2016 - [Red Tiger Mining Inc.](#) (TSXV: RMN) ("Red Tiger" or the "Company") announces that it has amended its senior secured loan between Minerales Libertad, S.A. de C.V. ("Minerales"), the Company's wholly-owned subsidiary, and Gerald Metals S.A. ("Gerald Metals").

Under the terms of the amendment:

- Gerald Metals has loaned Minerales an additional US\$400,000 for general working capital purposes.
- Tranche 1 under the Amended and Restated Loan Agreement has been split into Tranche 1A and 1B.
- Principal debt of US\$500,000 has been moved from Tranche 2 under the Amended and Restated Loan Agreement, to Tranche 1A. Pursuant to the amendment, Tranche 1A consists of US\$3,769,207 principal outstanding plus interest thereon.
- Tranche 1B consists of US\$400,000.
- The interest rate on Tranches 1A, 1B and 2 is 13% per annum.

The loan amendment is considered to be a related party transaction within the meaning of TSX Venture Exchange ("TSXV") Policy 5.9, which incorporates Multilateral Instrument 61-101 ("MI 61-101"). The Company is relying on the exemptions from the valuation and minority shareholder approval requirements of MI 61-101 contained in sections 5.5(a) and 5.7(a) of MI 61-101 in respect of such participation.

About Red Tiger Mining

Red Tiger is engaged in copper cathode production, and in the exploration and development of copper and gold projects through its wholly-owned subsidiary, Minerales Libertad, S.A. de C.V. ("Minerales") at San Antonio de la Huerta, in the state of Sonora, Mexico.

On July 1, 2013, Minerales placed the Luz del Cobre Copper Project, an open-pit, heap leach, copper recovery operation into commercial production. The Company has other prospects on its over eleven thousand-hectare concession at various stages of exploration, and is potentially a gold producer in the mid-term.

Red Tiger is listed on the TSX Venture Exchange (symbol "RMN"). The number of shares outstanding is 144,446,957.
