

Potash Corporation of Saskatchewan Inc. Announces Election of Directors

SASKATOON, May 10, 2016 - [Potash Corporation of Saskatchewan Inc.](#) (PotashCorp) (Symbol: POT, Listed: TSX, NYSE) announced that the thirteen nominees listed in the management proxy circular for the 2016 Annual and Special Meeting of Shareholders were elected as directors of PotashCorp earlier today at the shareholder meeting held in Saskatoon, Saskatchewan.

Detailed results of the vote for the election of directors held at the meeting are set out below.

At the meeting, shareholders also voted: (i) to approve the appointment of Deloitte LLP as auditors of the company (97.56% voted in favor), (ii) to approve the adoption of PotashCorp's 2016 Long-Term Incentive Plan (80.49% voted in favor), (iii) to approve the advisory resolution accepting PotashCorp's approach to executive compensation (92.50% voted in favor), and (iv) against a shareholder proposal (68.36% voted against).

PotashCorp is the world's largest crop nutrient company and plays an integral role in global food production. The company produces the three essential nutrients required to help farmers grow healthier, more abundant crops. With the global population rising and diets improving in developing countries, these nutrients offer a responsible and practical solution to meeting the long-term demand for food. PotashCorp is the largest producer, by capacity, of potash and among the largest in nitrogen and phosphate. While agriculture is its primary market, the company also produces products for animal nutrition and industrial uses. Common shares of Potash Corporation of Saskatchewan Inc. are listed on the Toronto Stock Exchange and the New

York Stock Exchange.
