TORONTO, Aug. 12, 2016 /CNW/ - <u>Uranium One Inc.</u> ("Uranium One") today reported quarterly headline revenue of \$127.3 million Q2 2016. Attributable revenue was \$137.5 million for Q2 2016 based on sales of 4.2 million pounds of produced material at an averaged sales price of \$31 per pound sold of produced material, with an average cash cost per pound sold of produced material at \$ per pound. Attributable production for the quarter was 3.1 million pounds.

Q2 2016 Highlights

Operational

- Total attributable production during Q2 2016 was 3.1 million pounds, compared to 3.2 million pounds during Q2 2015.
- The average total cash cost per pound sold of produced material reduced to \$11 per pound during Q2 2016, compared to \$14 pound during Q2 2015.

Financial

- Attributable sales volume of produced material for Q2 2016 was 4.2 million pounds sold, compared to 3.2 million pounds sold during Q2 2015.
- Headline revenue was \$127.3 million in Q2 2016, compared to \$111.0 million in Q2 2015.
- Attributable revenues consistent with the Corporation's segment reporting amounted to \$137.5 million in Q2 2016, compared t \$165.0 million in Q2 2015.
- The average realized sales price of produced material during Q2 2016 was \$31 per pound, compared to \$37 per pound in Q2 2015. The average spot price in Q2 2016 was \$27 per pound compared to \$37 per pound in Q2 2015.
- Gross profit, including the Corporation's share of gross profit from equity accounted investees, totaled \$50.5 million in Q2 2010 23% increase compared to \$41.1 million in Q2 2015, mainly due to an increase of 32% in sales volume, partly offset by a decrease of 16% in average realized sales price.
- The net earnings for Q2 2016 were \$24.5 million or \$0.03 per share, compared to net earnings of \$21.6 million or \$0.02 per sh for Q2 2015.
- The adjusted net earnings for Q2 2016 were \$47.8 million or \$0.05 per share after exclusion of other income of \$9.3 million, inventory valuation adjustment of \$21.4 million, impairment of non-current assets of \$4.9 million and net foreign exchange loss \$6.3 million, compared to an adjusted net earnings of \$7.8 million or \$0.01 per share for Q2 2015.
- In addition to the increase in sales volume during the quarter, improved profitability resulted from a reduction in General and Administrative costs and from other cost reduction initiatives.

Corporate Matters

- On June 29, 2016, the Corporation closed the tender offer for, and accepted for purchase, \$60.5 million of the principal amour
 the Senior Secured Notes at a price of \$1,000 per \$1,000 of face value. The total amount of the transaction was \$60.8 million
 including \$0.3 million of accrued interest, as well as legal and transaction fees. The Senior Secured Notes so purchased are h
 by the Corporation and have not been retired and remain outstanding. The settlement of the tender offer was completed on Ju
 2016.
- On July 12, 2016, the Corporation entered into a loan facility agreement under which it may borrow up to \$81.0 million from an affiliate, at an interest rate of up to 5.5% per annum with a maturity date of up to May 15, 2021, for the purpose of purchasing, redeeming or settling (respectively) the Senior Secured Notes, Series 1 Ruble Bonds, and/or any related currency exchange s agreements. The Corporation has not yet drawn down any amounts under this loan facility. On August 11, 2016, the Corporation and the affiliate agreed to increase the facility to \$95 million.

Q2 2016 Operations

During Q2 2016, Uranium One achieved total attributable production of 3.1 million pounds, compared to 3.2 million pounds during Q 2015.
