Gungnir Resources Inc: Closes First Tranche of Private Placement

Vancouver - <u>Gungnir Resources Inc.</u> (GUG: TSX-V) ("Gungnir" or the "Company") has closed the first tranche of its previously announced non-brokered private placement (the "Offering") by issuing 8,183,333 units for a total of CDN\$245,500. The final tranche of the Offering is expected to close next week and is expected to be fully subscribed.

The previously announced non-brokered private placement offering (September 2, 2016) consists of up to 12,000,000 units ("Units") at a price of \$0.03 per Unit to raise up to \$360,000. Each Unit will consist of one common share and one share purchase warrant, with each warrant exercisable to purchase one additional common share for a period of five years, subject to an acceleration clause as set out below, at an exercise price of \$0.05 per share.

In the event that the closing price of the Company's shares on the TSX Venture Exchange is \$0.20 per share or more for 21 consecutive trading days at any time subsequent to the expiry of six months from the date of issuance of the warrants, then Gungnir will earn the right, by providing notice to the warrant holders, to accelerate the expiry date of the warrants to that date which is 30 days from the date of the acceleration notice.

The Company has received a conditional waiver from the minimum \$0.05 price for private placements pursuant to the TSXV Bulletin dated April 7, 2014. Closing on the Offering is conditional upon final approval by TSXV.

The proceeds of the Offering will be used by Gungnir as future working capital and for exploration expenses in Sweden. The Offering is being allocated to subscribers on a "first come, first served" basis. Finders' fees will be paid by Gungnir in relation to this Offering.
