

TORONTO, ONTARIO--(Marketwired - Dec 6, 2016) - [Uranium Participation Corp.](#) ("UPC") (TSX:U) reports its estimated net asset value at November 30, 2016 was CAD\$388.5 million or CAD\$3.21 per share. As at November 30, 2016, UPC's investment portfolio consisted of the following:

On November 30, 2016, the common shares of UPC closed on the TSX at a value of CAD\$3.61, which represents a 12.46% premium to the net asset value per share of CAD\$3.21.

Uranium Purchases

In November 2016, UPC entered into agreements to purchase 560,000 pounds U₃O₈ at an average price of US\$20.57 per pound. The purchases were funded by the proceeds received by UPC in late October 2016, on the completion of an equity offering resulting in the issuance of 5,200,000 common shares for gross proceeds of \$20,020,000. As at November 30th, 2016, all deliveries have been received and are included in UPC's investments in uranium.
