

Blackhawk Resource Corp. Files Quarter Ended March 31, 2017 Financial Reports

CALGARY, May 29, 2017 - [Blackhawk Resource Corp.](#) ("Blackhawk" or the "Corporation") (TSX VENTURE:BLR) is pleased to announce that the financial statements and MD&A for its third quarter ended March 31, 2017 have been filed on Sedar.

- Blackhawk had interest income of \$123,009 on its debt portfolio, a realized gain on disposal of equity investments of \$78,987 and an unrealized gain on equity investments of \$2,618,365 for the period ended March 31, 2017.

- Blackhawk had cash flow from operations of \$113,512 for the period ended March 31, 2017.

- As at March 31, 2017, Blackhawk had \$5,823,666 in working capital.

- As at March 31, 2017, Blackhawk held \$5,724,876 in current investments.

- As at March 31, 2017, NAV per share was \$0.14.

Blackhawk continues to hold certain equity investments, and has begun to strategically focus its investments in e-sports. As part of this focus, the equity portion of its portfolio includes a significant investment in a private eSports company, UMG Media Corp. ("UMG"). UMG has involvement in both live tournament events as well as on line match play. On February 27, 2017, UMG completed an equity financing at \$1.50 per share which increases the fair value of Blackhawk's investment from \$1,358,000 to \$4,795,500.

PORTFOLIO INVESTMENTS

As at March 31, 2017, the Corporation held total investments of \$5,724,876 comprised of equity type investments of \$4,858,098 and debt type investments of \$866,778. In addition, the Corporation held a cash balance of \$76,640.
