

TORONTO, ONTARIO--(Marketwired - June 19, 2017) - [Magna Terra Minerals Inc.](#) ("Magna Terra" or the "Company") (TSX VENTURE:MTT) is pleased to announce the closing of the second tranche of its private placement for gross proceeds of \$108,500 bringing the total amount raised to \$794,546.
