The preliminary phase is a helicopter-borne vegetation geochemical survey that will allow us to cover a large area in a short time. This survey will better localize the source of the strong Tantalum-Niobium stream sediment geochemical anomalies that have been detected here. Once the results from this program are received the data generated will be assimilated into the dataset, and [Lithium Corp.](#) will then focus further geological and geochemical work in the areas of the claims determined to be most prospective.
