

Medgold Resources proposes \$1.0 million private placement

VANCOUVER, Sept. 24, 2018 - [Medgold Resources Corp.](#) (TSXV: MED) announces that it proposes, subject to stock exchange approval, to complete a non-brokered private placement financing of up to approximately 3.33 million units at \$0.30 per unit, for proceeds of up to \$1.0 million. Each unit will consist of one common share and one full warrant, each warrant entitling the holder to purchase one additional common share of the Company at \$0.40 for two years from closing. The warrants will be subject to an acceleration provision such that if the closing price of the Company's shares for 10 consecutive trading days is \$0.60 or greater, the Company may give notice to the holders of the warrants that the warrants will expire 30 calendar days after receipt of such notice. The Company may pay a finder's fee on a portion of this financing.

The proceeds of the placement are intended to be used for exploration of the Company's 100% owned Ljubata Project in Serbia, project generation and for general working capital purposes.
