

BE Resources Inc Announces Proposed Debt Settlement

TORONTO, May 09, 2019 - [BE Resources Inc.](#) (TSXV: BER.H) ("BE Resources" or the "Company") announces that it has reached agreements (the "Debt Settlement") with each of Marrelli Capital Limited, Marrelli Support Services Inc., DSA Corporate Services Inc., and DSA Filing Services Limited (the "Support Creditors") to settle an aggregate of \$51,167.23 in debt owed by the Company to the Support Creditors in respect of short-term operational loans made to the Company by Marrelli Capital Limited and in respect of indebtedness for corporate support services rendered to the Company by the Support Creditors. The Support Creditors have agreed to convert their collective indebtedness into common shares of the Company ("Common Shares") at a price of \$0.05 per Common Share, subject to receipt of the approval from the TSX Venture Exchange. It is expected that, upon the completion of the Debt settlement, subject to receipt of the requisite approvals, the Company will issue 1,023,343 Common Shares to the Support Creditors.

Any securities issued in connection with the Debt Settlement will be issued in reliance on certain prospectus and registration exemptions under applicable securities legislation and will be subject to a hold period of four months and a day.

Related Party Transactions

The issuance of Common Shares to Support Creditors, all corporations controlled by Carmelo Marrelli, a director of the Company, in connection with the Debt Settlement is a "related party transaction" pursuant to Multilateral Instrument 61-101 *Protection of Minority Security Holders in Special Transactions* ("MI 61-101"). The Company is relying on an exemption from the formal valuation requirements of MI 61-101 available on the basis of the Company not being listed on a specified stock exchange, including the Toronto Stock Exchange, the New York Stock Exchange, the American Stock Exchange, the NASDAQ and certain overseas exchanges. The Company is also relying on the exemption from minority shareholder approval requirements under MI 61-101, as the fair market value of the Common Shares issued to the Support Creditors under the Debt Settlement does not exceed 25% of the market capitalization of the Company, as determined in accordance with MI 61-101.

Early Warning Reports

Prior to the closing of the Debt Settlement, Mr. Marrelli beneficially owned 6,721,557 Common Shares (or approximately 31.48% of the total issued and outstanding Common Shares).

It is expected that upon the completion of Debt Settlement Mr. Marrelli will beneficially own 7,744,900 Common Shares (or approximately 34.6% of the Common Shares expected to be issued and outstanding then on a partially diluted basis).

The Common Shares are anticipated to be acquired by Mr. Marrelli for investment purposes, and depending on market and other conditions, he may from time to time in the future increase or decrease his ownership, control or direction over securities of the Company through market transactions, private agreements, or otherwise.
