VANCOUVER, December 15, 2020 - Northern Lights Resources Corp. (CSE:NLR) (the "Company" or "Northern Lights") is pleased to announce that it has entered into an Investor Relations Agreement with Mr. Shawn Balaghi of Ascent Corporate Management Inc. In consideration for the services, the Company will pay the Consultant \$6,500 on a monthly basis. The Company has, subject to regulatory approval, granted the Consultant stock options entitling the Consultant to purchase 500,000 common shares of the Company at a price of \$0.07 per share with a five year term.
