Denison Completes Commissioning of Lixiviant Injection Modules for Phoenix ISR Feasibility Field Test

TORONTO, Sept. 26, 2022 - <u>Denison Mines Corp.</u> ("Denison" or the "Company") (TSX: DML) (NYSE American: DNN) to announce the completion of commissioning of the lixiviant injection system for the Phoenix in-situ recovery ("ISR") Field Test ("FFT") at the Company's 95% owned Wheeler River project ("Wheeler River" or the "Project"). The lixiviant system is the critical operating component necessary to support the leaching phase of the FFT. View PDF version.

Kevin Himbeault, Denison's Vice President of Plant Operations & Regulatory Affairs, commented, "With the completion construction and wet commissioning of the injection modules, we have now successfully commenced our initial injection into the test area, which represents the beginning of the leaching phase of the FFT."

David Cates, Denison's President and CEO, added, "We are proud of this notable milestone, particularly given the exte coordination and efforts of Denison's Saskatoon-based technical team and our various construction partners that have on the safe and timely construction and commissioning of this first-of-its-kind test facility."

Limited construction activities continue on-site to support future phases of the FFT (discussed below). Construction effort feet are being completed in collaboration with Tron Construction & Mining, a well-established operator in northern Sasl that is part of the Des Nedhe Group and owned 100% by English River First Nation. Civil earthworks for the FFT are su completed, and continue to be supported by Snake Lake Contracting, another northern Saskatchewan-based and Indigenous-owned business.

This press release constitutes a "designated news release" for the purposes of the Company's prospectus supplement September 28, 2021 to its short form base shelf prospectus dated September 16, 2021.

Background on the FFT

The FFT is designed to use the existing commercial-scale ISR test pattern ("Test Pattern"), installed at Phoenix in 2027 releases dated July 29, 2021, and October 28, 2021), to facilitate a combined assessment of the Phoenix deposit's hydroperties with the leaching characteristics that have been assessed through the metallurgical core-leach testing programmer.

The FFT is fully permitted, having been authorized by both the Saskatchewan Minister of Environment (see news released up 12, 2022) and the Canadian Nuclear Safety Commission (see news release dated August 8, 2022).

Overall, the FFT is intended to provide further verification of the permeability, leachability, and containment parameters the successful application of the ISR mining method at Phoenix and is expected to validate and inform various feasibilit design elements - including the expected production and remediation profiles.

The operation of the FFT is planned to occur in three phases: (1) the leaching phase, (2) the neutralization phase, and recovered solution management phase.

The leaching phase is designed to assess the effectiveness and efficiency of the leaching process in the mineralized zo is approximately 400m below the surface. The leaching phase includes the controlled injection of an acidic solution into of the existing Test Pattern within the mineralized zone (the "Leaching Zone") and the recovery of the solution back to tusing existing test wells. The recovered solution from the leaching phase is expected to contain dissolved minerals, incuranium, copper, iron, molybdenum, and zinc.

The neutralization phase involves the recovery of the remainder of the leached mineralized solution from the Leaching intended to verify the efficiency and effectiveness of the process for returning the Leaching Zone to environmentally acconditions. During this phase, a mild alkaline (basic) solution will be injected into the Leaching Zone to neutralize the arreverse the residual effects of the acidic solution injected during the leaching phase.

The recovered solution management phase involves separating the solution recovered from both the leaching phase an neutralization phase into (i) mineralized precipitates and (ii) a neutralized treated solution.

About Wheeler River

Wheeler River is the largest undeveloped uranium project in the infrastructure rich eastern portion of the Athabasca Ba in northern Saskatchewan - including combined Indicated Mineral Resources of 132.1 million pounds U₃O₈ (1,809,000 an average grade of 3.3% U₃O₈), plus combined Inferred Mineral Resources of 3.0 million pounds U₃O₈ (82,000 tonness)

average grade of 1.7% U₃O₈). The Project is host to the high-grade Phoenix and Gryphon uranium deposits, discovere Denison in 2008 and 2014, respectively, and is a joint venture between Denison (operator) and JCU (Canada) Explorate Company Limited ("JCU"). Denison has an effective 95% ownership interest in Wheeler River (90% directly, and 5% interest in JCU).

A PFS was completed for Wheeler River in 2018, considering the potential economic merit of developing the Phoenix of an ISR operation and the Gryphon deposit as a conventional underground mining operation. Taken together, the Project estimated to have mine production of 109.4 million pounds U₃O₈ over a 14-year mine life, with a base case pre-tax NPV billion (8% discount rate), Internal Rate of Return ("IRR") of 38.7%, and initial pre-production capital expenditures of \$3 million. The Phoenix ISR operation is estimated to have a stand-alone base case pre-tax NPV of \$930.4 million (8% dis IRR of 43.3%, initial pre-production capital expenditures of \$322.5 million, and industry-leading average operating costs US\$3.33/lb U₃O₈. The PFS is prepared on a project (100% ownership) and pre-tax basis, as each of the partners to the River Joint Venture are subject to different tax and other obligations.

Further details regarding the PFS, including additional scientific and technical information, as well as after-tax results at to Denison's ownership interest, are described in greater detail in the NI 43-101 Technical Report titled "Pre-feasibility Sthe Wheeler River Uranium Project, Saskatchewan, Canada" dated October 30, 2018, with an effective date of Septem 2018. Denison suspended certain activities at Wheeler River during 2020, including the EA process, which is on the critical parachieving the project development schedule outlined in the PFS. While the EA process has resumed, the Company is rable to estimate the impact to the project development schedule outlined in the PFS, and users are cautioned against rathe estimates provided therein regarding the start of pre-production activities in 2021 and first production in 2024.

Denison is a uranium exploration and development company with interests focused in the Athabasca Basin region of no Saskatchewan, Canada. In addition to its effective 95% interest in the Wheeler River project, Denison's interests in the Basin include a 22.5% ownership interest in the McClean Lake joint venture, which includes several uranium deposits a McClean Lake uranium mill that is contracted to process the ore from the Cigar Lake mine under a toll milling agreement 25.17% interest in the Midwest Main and Midwest A deposits, and a 67.01% interest in the Tthe Heldeth Túé ("THT," for Zone) and Huskie deposits on the Waterbury Lake property. The Midwest Main, Midwest A, THT and Huskie deposits a located within 20 kilometres of the McClean Lake mill.

Through its 50% ownership of JCU, Denison holds additional interests in various uranium project joint ventures in Canal including the Millennium project (JCU 30.099%), the Kiggavik project (JCU 33.8118%) and Christie Lake (JCU 34.4508 Denison's exploration portfolio includes further interests in properties covering approximately 300,000 hectares in the ABasin region.

Denison is also engaged in post-closure mine care and maintenance services through its Closed Mines group, which me Denison's reclaimed mine sites in the Elliot Lake region and provides related services to certain third-party projects.
