

# Patriot Announces Inclusion in the S&P/ASX 300 Index

SYDNEY and VANCOUVER, BC, Sept. 6, 2023 /CNW/ - [Patriot Battery Metals Inc.](#) (the "Company" or "Patriot") (TSXV: PMT) (ASX: PMT) (OTCQX: PMETF) (FSE: R9GA) is pleased to announce that common shares of the Company (ASX: PMT) have been selected for inclusion in the Standard & Poors ("S&P")/ASX 300 Index by the S&P Dow Jones effective prior to ASX opening on September 18, 2023.

Blair Way, Company President and CEO, comments, "We are very pleased that Patriot has been selected for inclusion in the S&P/ASX 300 Index. Over a short timeframe, the team has advanced our Corvette Property into a world-class lithium deposit. The market for lithium is still growing. Inclusion in this index recognizes our increased market capitalization and trading liquidity prompted by our recent financing, the development of our flagship Corvette hard rock spodumene lithium deposit located in the Eeyou Istchee James Bay region of Quebec. This inclusion to the S&P/ASX 300 Index places Patriot among the 300 largest securities traded on the ASX. This inclusion will also help increase our trading liquidity through incremental demand for our shares in Australia from institutional investors and asset managers who track the composition of the Index and benchmark their performance against it."

The S&P/ASX 300 is designed to provide investors with broader exposure to the Australian equity market. The index measures the performance of Australia's largest highly liquid securities listed on the ASX by float-adjusted market capitalization. The S&P/ASX 300 Index covers the large-cap, mid-cap, and small-cap components of the S&P/ASX Index Series. This index is designed to provide investors with broad exposure to the Australian equity market while allowing them to benchmark against a wide selection of investment opportunities based on specific size and liquidity parameters.

Currently, Patriot's shares are included in two North American indices, the MVIS Global Rare Earth/Strategic Metals Index and the S&P/TSX Battery Metals Index on the Toronto Stock Exchange. The inclusion in these indices led to increased ownership by international institutional investors in North America, and the Company anticipates that its inclusion in the S&P/ASX 300 index may result in increased institutional ownership in Australia as well.

[Patriot Battery Metals Inc.](#) is a hard-rock lithium exploration company focused on advancing its district-scale 100% owned Corvette Property located in the Eeyou Istchee James Bay region of Quebec, Canada, and proximal to regional road and power infrastructure. The Corvette Property hosts the CV5 Spodumene Pegmatite with a maiden inferred mineral resource estimate of 109.2 Mt at 1.42% Li<sub>2</sub>O and 160 ppm Ta<sub>2</sub>O<sub>5</sub> (at a cut-off of 0.40% Li<sub>2</sub>O) and ranks as the largest lithium pegmatite resource in the Americas, and one of the top 10 largest lithium pegmatite resources in the world. Additionally, the Corvette Property hosts several other spodumene pegmatite clusters that remain to be drill tested, as well as more than 20 km of prospective trend that remains to be assessed.
