Vancouver, September 14, 2023 - <u>Starcore International Mines Ltd.</u> (TSX: SAM) ("Starcore" or the "Company") reports the results for the first quarter ended July 31, 2023, for the Company and its mining operations in Queretaro, Mexico. All financial information is prepared in accordance with IFRS and all dollar amounts are expressed in thousands of Canadian dollars unless otherwise indicated.

"Our quarterly production reflects our recent difficulties in reaching our higher-grade ore bodies or stopes," stated Robert Eadie, Chief Executive Officer. "We expect to achieve our targets over the remainder of the year as we are currently completing the development to the high-grade zones."

- Cash on hand is \$5.7 million and working capital of \$6.2 million at July 31, 2023;
- Gold and silver sales of \$6.23 million;
- Loss from mining operations of \$0.75 million;
- Loss of \$1.7 million, or \$0.03 per share;
- EBITDA¹ loss of (\$0.8) million;
