

Myriad Uranium Corp. to Conduct Digital and Television Marketing Program

Vancouver, February 1, 2024 - [Myriad Uranium Corp.](#) (CSE: M) (OTCQB: MYRUF) (FSE: C3Q) ("Myriad" or the "Company") is pleased to announce that it will be conducting a digital and television marketing campaign, including digital marketing on top financial sites such as BNN Bloomberg, Forbes, Yahoo Finance, Seeking Alpha, the Financial Post and Market Watch, as well as TV spots on BNN Bloomberg.

Myriad's CEO Thomas Lamb commented, "We have an exciting few months ahead of us and we want to maximize our reach. Each of MW and BS is arm's length to Myriad and, to the knowledge of Myriad, none of MW, BS or their principals have any present equity interest in the Company's securities, directly or indirectly, or any right to acquire any equity interest. About Myriad Uranium Corp.

[Myriad Uranium Corp.](#) is a uranium exploration company with an earnable 75% interest in the Copper Mountain Uranium Project in Wyoming, USA. Copper Mountain hosts several known uranium deposits and historic uranium mines, including the Arrowhead Mine which produced 500,000 lbs of eU_3O_8 . Copper Mountain saw extensive drilling and development by Union Pacific, which developed a mine plan and built a leach pad for one of the deposits at Copper Mountain. Operations ceased in 1980 before mining could commence due to falling uranium prices. Approximately 2,000 boreholes have been drilled at Copper Mountain and the project area has significant exploration upside. Union Pacific is estimated to have spent C\$117 million (2023 dollars) exploring and developing Copper Mountain, generating significant historical resource estimates which are detailed here.

Myriad also holds 80% ownership of over 1,800 km² of uranium exploration licenses in the Tim Mersoui Basin, Niger, with the option to earn up to 100%. These licenses are surrounded by many of the most significant uranium deposits in Africa, including Orano's 384 Mlbs eU_3O_8 Imouraren, Global Atomic's 236 Mlbs Dasa, and Goviex's 100 Mlbs Madaouela, and on the same fault structures. Myriad also has a 50% interest in the Millen Mountain Property in Nova Scotia, Canada, with the other 50% held by Probe Metals Inc.
