

# Eldorado Gold Provides Update on First Quarter 2024 Tax Impacts in Türkiye; and Provides Conference Call Details

VANCOUVER, April 09, 2024 - [Eldorado Gold Corp.](#) ("Eldorado" or the "Company") today provides the following updates on the tax impacts in Türkiye related to the weakening of the Turkish Lira in Q1 2024.

## Tax Impacts in Türkiye for Q1 2024 Related to the Weakening Turkish Lira

The Company's profits from mining operations in Türkiye are taxed at the enacted rate and the resulting current income tax expense can be further increased or reduced by other items. For the first quarter, the Company expects the Turkish current income tax expense on mining profits, at an enacted rate of 25%, to be further decreased by \$9 to \$12 million. The estimated decrease is primarily attributable to investment tax credits relating to Kisladag and Efemcukuru, and the effects of inflation accounting, partly offset by taxable unrealized foreign exchange gains due to the weakening of the Lira, against the US dollar, in the quarter.

## Q1 2024 Financial and Operational Results Call Details
