[Renforth Resources Inc.](#) (CSE: RFR) (OTC: RFHRF) (FSE: 9RR) ("Renforth" or the "Company"), is pleased to advise shareholders that Renforth will have a booth at the Munich Mining Conference, October 3rd and 4th, and presenting to conference attendees on October 4th at 10am local time. The conference has 109 companies attending and more than 1,000 individual investors registered to attend. If you are in attendance, please stop by booth #11 and say hello.

Renforth's recent efforts have been directed towards advancing our maiden Mineral Resource Estimate (MRE) for the Victoria mineralized system where we are working to declare a maiden nickel polymetallic resource over the ~2.5km of strike we have drilled within the ~20km long Victoria structure. As previously stated, the release of this estimate is anticipated in the fall.

In addition, we have obtained new detailed geophysical data covering an area just east of our Beaupré discovery on our Malartic Metals Package property, as well as a portion of our Parbec gold deposit, covering the northwestern part of the property. This data covers nearly half of the Cadillac Break within the property, and importantly, the Pontiac sediments to the south of the Break, which incorporate the Diorite splay and our permitted stripping location. Renforth obtained this data as we allowed our neighbor to fly over our ground, simplifying their survey work, in exchange for the information at no cost. This new data is being integrated into our project data and evaluated.
