TORONTO, ONTARIO -- (Marketwire - Dec. 30, 2010) - [Baffinland Iron Mines Corporation](#) (TSX:BIM) (the "Company") announced today that it has received notice by way of press release that ArcelorMittal has extended its offer being made to holders of the Company's Common Shares and 2007 Warrants. Under the ArcelorMittal Offer, holders of Common Shares will receive C\$1.25 in cash per share and holders of 2007 Warrants will receive C\$0.10 in cash per warrant. The ArcelorMittal Offer has been extended until 11:59 p.m. (Toronto time) on January 10, 2011, unless further extended or withdrawn.

Baffinland is a Canadian publicly-traded junior mining company that is focused on its wholly-owned Mary River iron ore deposits located on Baffin Island, Nunavut Territory, Canada. Baffinland's shares trade on the Toronto Stock Exchange under the trading symbol BIM.
